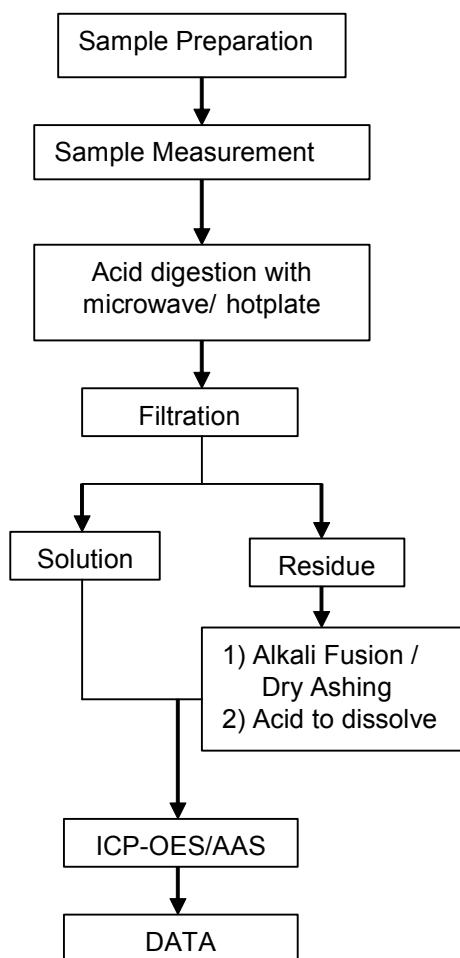

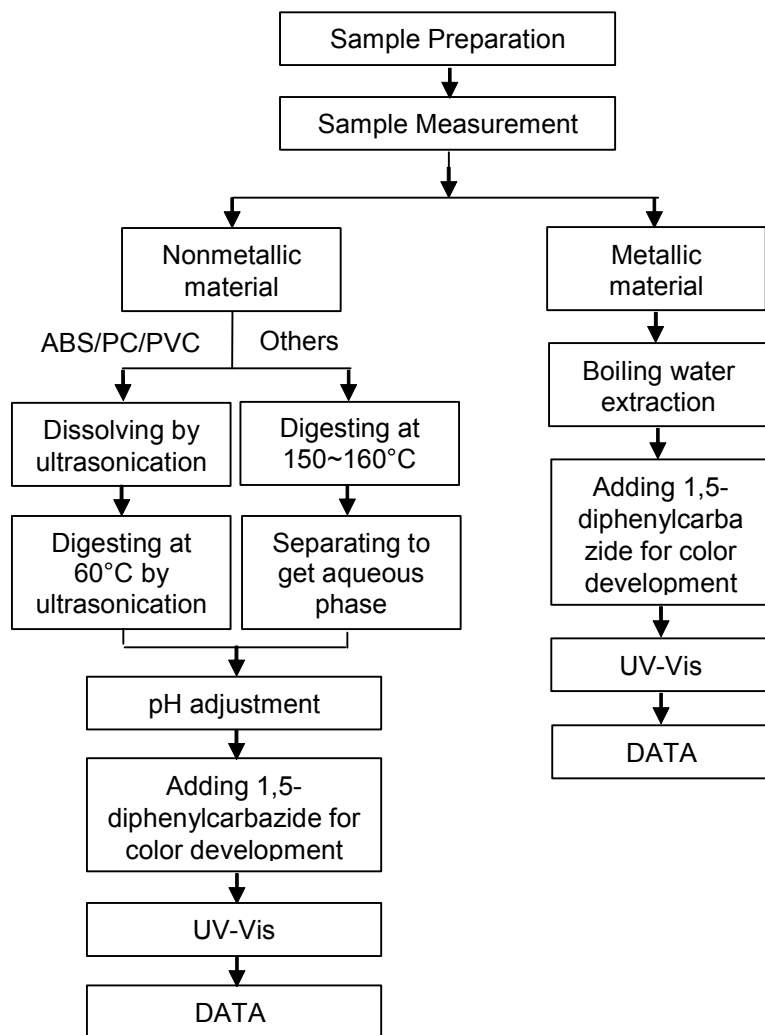
### Pb / Cd / Hg Testing Flow Chart

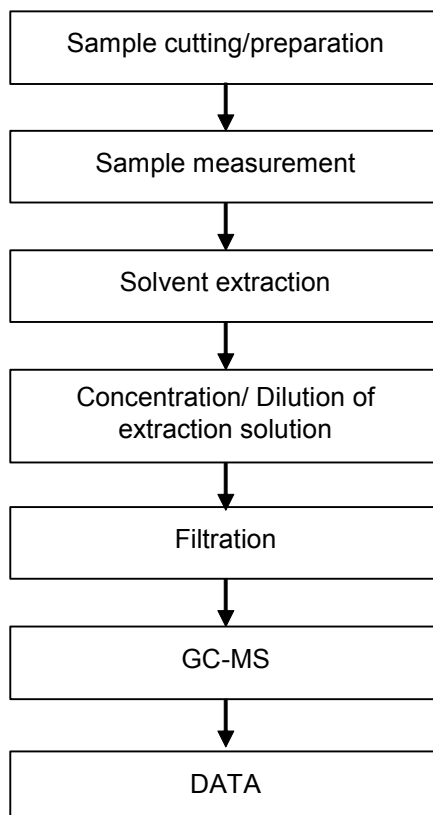
### Hexavalent Chromium (Cr(VI)) Testing Flow Chart

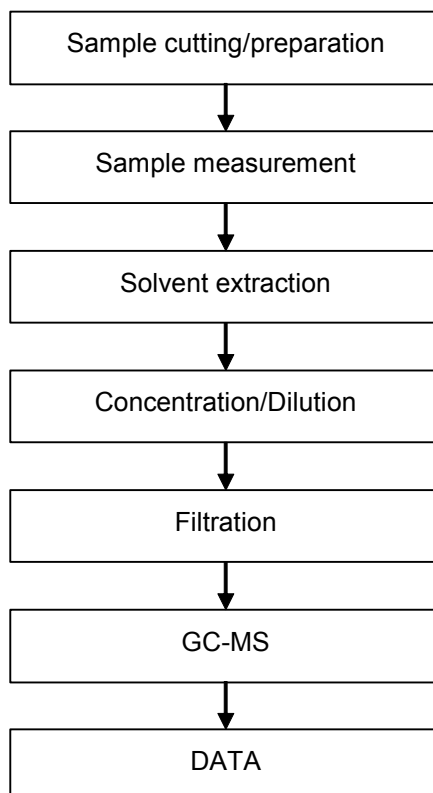

### Phthalates Testing Flow Chart



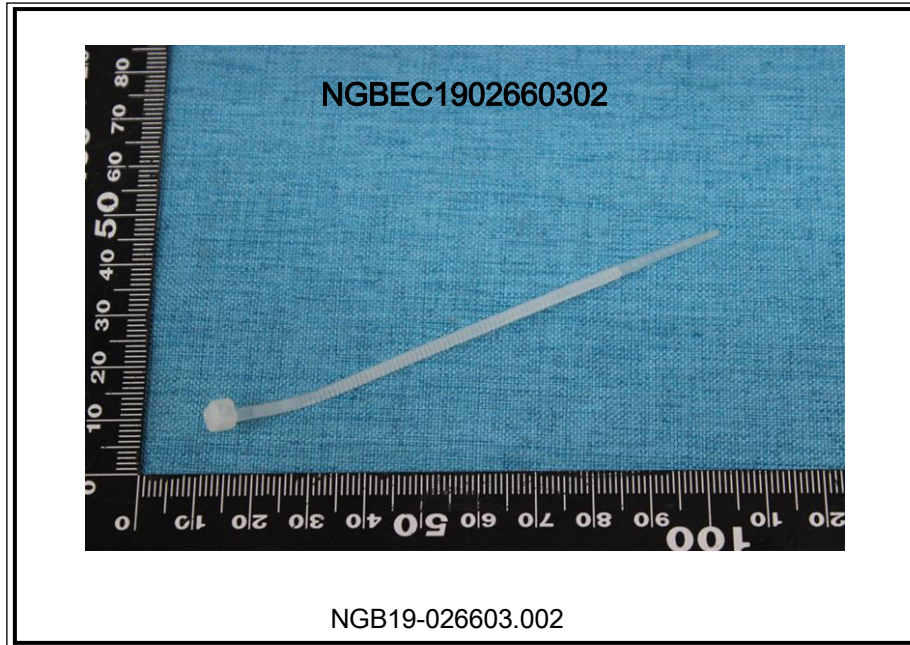
